

Mandan Park District
Board Meeting Minutes
November 9, 2015

The Board of Park Commissioners duly met in regular session on Monday, November 9th, 2015 at Ed "Bosch" Froehlich Meeting Room, City Hall. Those present were President Arenz, Commissioner McPherson, Commissioner Allan, and Commissioner Hatzenbuhler.

President Arenz called the meeting to order at approximately 5:30 pm, CDT. President Arenz asked for approval of the minutes for October 12, 2015 regular meeting and November 3, 2015 special meeting. Motion was made by Commissioner McPherson, seconded by Commissioner Allan. Motion passes.

Unfinished Business:

- Section 1.) Consider for approval agreement with the Mandan Hockey Club for financial commitment towards Sports Complex. Director Higlin stated that there were some revisions of the agreement portion section 2. Spelled out the exact rooms that allow the Mandan Hockey Club to go out and get sponsorships for. Spells out the commitment of a half million dollars on April 1, 2016 and a half million on April 1, 2017. Motion made by Commissioner Allan, seconded by Chad Hatzenbuhler. Motion passes.

New Business:

- Section 1.) Consider for approval for Slide the City 2016 dates. Kelly Churchill, Marketing recommended bringing Slide the City back August 27th, 2016. The 2015 Slide the city brought \$9,500 approximate dollars to the Universal Playground. This year we would contribute to a development for the park or something that would benefit the community. It also brought in approximately 5,000 spectators or slide goers. This year we would have a committee based off Mandan Park District Staff and pending MPO approval they would also be onboard. City commission is set up for the meeting for November 17th. Subject to city commission, regardless of MPO we will be putting on the event if approved. If we do partner with MPO we plan to make that a bigger event. Motion made by Commissioner McPherson, seconded by Commissioner Allan. Motion passes.
- Section 2.) Update on the 2016 Millennium Trail rehabilitation project. Director Higlin stated a grant was awarded back in June in the amount of \$253,644.00 and that is to repair the Millennium Trail from the Fort Lincoln Trolley to 19th St. SE along highway 1806. It will be submitted December 1st to get part of the spring bid opening with NDDOT. November 2014 we submitted the grant application, we also had included KLJ Engineering estimates for \$53,000 at that time. They now submitted the contract associated with it and it is not in the minutes reflecting that we accepted that in addition to it. We accepted applying for the grant knowing what the fees were at that time. But we do have to include the \$53,000 KLJ for these services. That is part of the grant funding. Motion made by Commissioner Allan, seconded by Commissioner Hatzenbuhler. Motion passes.
- Section 3.) Consider for approval to petition the street improvement project for 16th St NE east of the Mandan Sports Complex. It would be a shared 50/50 special assessment with the adjacent landowners. In order to petition the city both land owners have to agree to submit this petition which means to not oppose any specials being assessed to your property for that street project which include curb, gutter and

streetlights. This is a motion to start the petition. Wouldn't have to bring the petition back because the adjacent landowner has to approve their portion of it first. Motion was made by Commissioner Allan, seconded by Commissioner McPherson. Motion passes

Director Higlin stated that an additional bill has to be added. It was submitted wrong to billing. In the amount of \$1800.00 to the Horse and Saddle Club for their matching grant that was awarded back in February, so when we do the bills we would like to add that Horse and Saddle as part of that payment.

Kara Haff, Marketing manager stated that Raging Rivers is gearing up for the \$75 season pass sale which will kick off the week of Black Friday and run through cyber Monday and after that the price goes back up to \$90, \$110 in the spring and back up to the full \$140 during the core of the season.

Dave Frueh, Recreation Manager stated that last week he was in Louisville, KY bidding for the National softball tournament. We were successful and will have the 2017 class E Rec National Tournament Labor Day weekend, so it will be September 1st through the 3rd. Last time we hosted that tournament we had 63 teams so it should be close to that amount. May not get that amount but maybe between 45 and 55 would be a good number. Also we were lobbying for the 35 and over masters tournament for this coming year which is not approved by ASA yet but it is a possibility we will host that tournament too August 26th through the 28th along with the Mandan Softball association will end up spearheading that tournament along with my help and Mikes staff for maintenance. It's not approved 100% but hopefully get approval in the next month or so.

Authorization of payments of the monthly bills: This consists of the change with the Horse and Saddle Club. A motion was made by Commissioner McPherson, seconded by Commissioner Allan. Motion passes.
